**FWA & MAJIC'S PACK & FLY
OFFICIAL RULES**

1. How to Enter the Contest:

- a. The "Pack & Fly" contest will begin on Monday, January 30, 2012 and end on Thursday, February 16, 2012.

There are two ways to win:

One: Listen to WAJI Majic 95.1

To participate in this contest listen each weekday from 9am to 5pm for the call solicit. When you hear it, be the designated caller at (260) 467-9500 or 1-877-951-9254 and win a pair of tickets to the 2012 Home & Garden Show. You will also be a finalist to win round trip airfare for two (2) from Fort Wayne to Tampa Bay/St. Petersburg, Florida, hotel accommodations for three (3) nights and transfers. (WAJI is not responsible for telephone service outages, delays, busy signals or telephone malfunctions and other difficulties that may prevent the individual from completing his/her call during this contest.)

Two: Register at the airport on Thursday, February 16

On Thursday, February 16, 2012, from 3pm-6pm you may fill out an entry blank at the Fort Wayne International Airport, Fort Wayne, IN. You and your guest must be packed to travel that evening and have proper ID for security and airline purposes. Contestant may only fill out an entry form for themselves, and no one else. One entry allowed per person. Winner and Guest MUST BE present to win. Neither the Winner nor any Guest shall be eligible for a refund of the value of the tickets awarded nor for a refund of the cost of any Allegiant Air tickets which the Winner and/or Guest already holds for the date of departure and/or the date of return.

- b. There will be a total of 13 contest days. There will be a maximum of 36 on-air qualifiers for this contest. There will be two (2) winners of a trip for two (2) to Tampa Bay, Florida, one (1) on air, and one (1) on site.

2. Eligibility Restrictions:

- a. The portion of contest that is radio call-in to qualify is open to all **WAJI** listeners who are **21** years of age or older and who reside in the following counties in Indiana: Adams, Allen, Dekalb, Huntington, Kosciusko, Noble, Steuben, Wells and Whitley. In Ohio: Defiance, Paulding and Van Wert counties. The second part of contest "registering at the airport on Thursday, February 16, 2012, is open to all who are 21 years of age or older and who reside in the above-mentioned counties for Indiana and Ohio. Employees of Sarkes Tarzian, Inc., the Greater Fort Wayne Chamber of Commerce, Fort

Wayne-Allen County Airport Authority, Allegiant, participating sponsors/promotional partners, other radio stations in the Fort Wayne metro area and the members of their immediate families are ineligible to participate or win. Immediate family members are defined as parents, in-laws, children, spouses, those in spouse-like relationship, and siblings (including those in step- and half-relationships when living in the same household). Anyone who has worked or interned with Sarkes Tarzian, Inc. is also ineligible.

- b. Eligible participants can win a major WAJI contest a prize valued at \$600 or more only once every six months. One winner per household is permitted in this contest.

3. Prizes:

- a. On air qualifiers will win a pair of 2012 Home & Garden Show tickets and be a finalist to win round trip airfare for two (2) from Fort Wayne aboard Allegiant to Tampa Bay/St. Petersburg, Florida, hotel accommodations for three (3) nights and transfers. The approximate value of the qualifying prize is: \$20.00. The approximate value of the trip is: \$1100.00. Note: Baggage fees are excluded. On air winner is responsible for payment of any baggage fees. On air winner will have 30 days to claim their travel certificate or it will be forfeited. On air winner will have one year to use their travel certificate based on availability. The qualifying prize of Home and Garden Show tickets not claimed before February 20, 2012 will be forfeited by the qualifiers. If any prize or prize certificate is forfeited, it will become the property of WAJI.
- b. The airport on site winner on February 16, 2012 will receive round trip airfare for two (2) from Fort Wayne aboard Allegiant to Tampa Bay/St. Petersburg, Florida, hotel accommodations for three (3) nights and transfers leaving that night and returning February 19, 2012. The approximate value of the trip is: \$1100.00. Note: Baggage fees are excluded. Winner is responsible for payment of any baggage fees. Airport on site winner and guest on February 16, 2012 must be able to travel February 16-19, 2012. Airport on site winner must claim travel certificates on February 16, 2012 or it will be forfeited. If any prize or prize certificate is forfeited, and alternate winner will not be selected.

- b. On air qualifiers will need to listen for their name on Wednesday, February 15, 2012, at approximately 7:30am during Majic in the Morning. They will

have one minute to call back to claim the trip. If they do not call back within the allotted time, another name will be randomly chosen and announced. This process will continue until there is one (1) winner.

- c. On Thursday, February 16, 2012 at approximately 6:15pm, one name will be randomly drawn from all entries submitted on location at the Fort Wayne International Airport. Multiple entries will disqualify the entrant. At the end of the 3 hour period, a staff member will sort through the entry box to discard any multiple entries and then will randomly draw one (1) winning name from among all entries submitted. That person will be notified immediately inside the location. Winning entrant will have two minutes to respond after name called to claim prize. If no response in two minutes, another name will be randomly chosen and announced. This process will continue until there is one (1) winner. Upon confirming their identity with a government issued current photo ID, the winner and their guest must sign all paperwork and must be packed and able to travel immediately on the departing Allegiant Air flight to Tampa Bay that evening or will forfeit the prize and another name will be randomly chosen.
